Remuneration

(Law no. 53/2003 - The Labour Code, republished, as subsequently amended and supplemented - Articles> 159 - 165)

The salary constitutes the work performed by the employee based on an individual labour/employment contract.

Each employee shall have the right to a wage expressed in money for their activity performed under the individual labour contract.

The salary includes the basic salary, allowances, bonuses and other additions.

Individual salary is established through personal negotiations between the employer and the employee.

The salary is confidential.

The minimum gross salary guaranteed in payment is established by a Government's Decision, after consultation with trade unions and employers' organisations.

The employer is obliged to guarantee the payment of a monthly gross salary that is at least equal to the minimum gross national salary.

For employees whose employer provides food, accommodation or other facilities, the amount of the money due for the work performed may not be less than the statutory minimum gross national salary.

According to Government's Decision no. 935/2019, starting with January 1, 2020, the minimum gross basic salary per country guaranteed in payment, the amount set in money not including bonuses or other additions **is set at 2230 lei per month**, for a normal average work schedule of **167,333 hours per month**, representing 13,327Lei / hour.

According to Government's Decision no. 937/2018, starting with January 1, 2019, the minimum gross basic salary per country guaranteed in payment, the amount set in money not including bonuses or other additions **is set at 2080 lei per month**, for a normal average work schedule of **167,333 hours per month**, representing 12.43 Lei / hour.

By way of exception to the above-mentioned stipulations, starting January 1, 2019, for the staff assigned to **higher education positions with at least one year of senior work experience in the field of higher education**, the minimum basic salary on the guaranteed country in payment, excluding bonuses and other additions, **increases** from 2080 Lei **to 2350 lei per month**, for a normal work schedule of 167,333 hours on average per month, representing **14,044 lei / hour**.

By way of derogation from the provisions of Article 164 paragraph 1 of the Law no. 53/2003 - Labor Code, republished, with the subsequent modifications and completions, for the **period January 1 - December 31 2019, for the construction field**, the gross minimum salary on the country, guaranteed in payment is established in money, without any bonuses and other additions, at the amount of **3000 lei / month**, for a normal work schedule averaging 167,333 hours per month, representing 17,928 Lei / hour.

The aforesaid provisions apply exclusively to the fields of activity provided under art. 66 pt.1 of the Emergency Ordinance no. 114/2018.
